Specific accomplishments include:

- -Senior FBI representative to Belgium, Luxembourg, the Netherlands, NATO, and the EU. Coordinated multiple international counterterrorism, counterespionage, and nuclear proliferation investigations and operations. Significant portfolio of US-EU law enforcement policy development and implementation.
- -Senior Executive Service (SES) appointment as the On-Scene Commander for all FBI operations in Iraq, directing 100+ personnel. Coordinated with DOD in combat operations, counterinsurgency, intelligence, explosives, hostage recovery, major criminal investigations, and judicial and civilian infrastructure development.
- -Awarded the Service to America Medal and named Federal Employee of the Year in 2004 for work with Greek counterterrorism agents to identify, arrest, and prosecute the lethal "November 17" terrorist organization before the 2004 Olympic Games. Prior to their arrests, the November 17 terrorists had for 25 years conducted multiple attacks, bombings

and assassinations of US and international diplomatic and military personnel, Greek officials and industrialists, and other victims without a single member being identified.

- -Established and directed the FBI's Mara Salvatrucha (MS-13) National Gang Task Force and led multi-agency efforts to combat violent transnational street gangs. Deployed throughout Central America to garner international cooperation. Testified before Congressional and Cabinet-level officials on a regular basis.
- -Developed and supervised a four-year undercover operation that penetrated, covertly monitored, and dismantled a Hezbollah terrorist cell in Charlotte, NC that was raising funds for the Hezbollah terrorist organization through cigarette smuggling, financial fraud, and other criminal activity. This case was the first time a terrorist group was named as the association in fact in a mafia-style RICO prosecution and set the legal precedent for the Material Support to Terrorism statute, now used in virtually all US terrorism prosecutions.
- -Led the investigation and capture of Abu Nidal terrorist Omar Rezaq, whose hijacking of Egyptair Flight 648 resulted in the deaths of 61 passengers. The rendition of Rezaq out of Nigeria resulted in Rezaq's conviction of Air Piracy in US federal court, setting legal precedent, and becoming a model for subsequent extraterritorial operations, terrorist renditions, and federal extraterritorial jurisdiction prosecutions.
- -Conducted one of the FBI's first successful extraterritorial investigations in Latin America, leading a two-year investigation in Bolivia, resulting in the capture of Bolivian terrorists who had bombed Secretary of State George Schultz' motorcade and assassinated two Mormon missionaries.
